4. I authorize the Association to represent me in relation to any legal action taken against my employer to enforce my conditions of employment
5. I acknowledge that any or all of the above authorities may only be withdrawn by me with the permission of the Association, or as a result of my resignation from membership of the Association after a one month period of notice has been served.
6. I acknowledge the right of the Association to decline to represent me or offer me assistance in relation to any matter that arose prior to my making this application for membership.
